MELT-N-GRIP is a specially formulated blend which combines the safe and effective melting power of magnesium chloride with the gripping power of traction sand, all in one convenient product.

USES AND ADVANTAGES

- Quickly deices walks, driveways, stairs, etc..
- Magnesium chloride gives off heat as it dissolves.
- Traction sand provides superior gripping power on most surfaces.
- Leaves no white residue.
- Safe for plants and vegetation.

SURFACE PREPARATION

If snow is more than two inches deep, shovel or plow before applying.

APPLICATION

- Evenly apply 2 to 4 ounces (1/4 to 1/2 cup) of Melt-n-Grip to each square yard where deicing and traction are desired.
- Do not over apply.
- Allow Melt-n-Grip to work approximately 10 minutes to melt the bond between the ice and the surface.
- Remove melted ice and snow.
- Reapply for maximum gripping and melting power.
- Keep container tightly closed when not in use.

PRECAUTIONS

Independent testing shows that the magnesium chloride in Melt-n-Grip is safer to use on concrete surfaces than most commonly used deicers like rock salt. However, all snow and ice melters

may be harmful when used excessively or repeatedly on concrete surfaces. Quality concrete is considered to be air entrained concrete that is designed to withstand the damage associated with naturally occurring freeze-thaw cycles. Use of any ice melting agent may increase the number of freeze-thaw cycles. The frequency is also controlled by weather itself. When used in heavy and repeated applications, Melt-n-Grip may contribute to scaling or flaking of concrete surfaces. In order to reduce the risk of scaling or flaking, quickly remove the slush that results from the melted ice and snow.

WARNING!

Contains magnesium chloride and silica sand. May be irritating to the eyes and nose. Prolonged inhalation may cause lung damage. Avoid contact with eyes, skin and clothing. Do not swallow. In case of eye contact, flush with plenty of water for at least 15 minutes. For skin contact, remove contaminated clothing and wash skin thoroughly with water.
